
## AMERICAN-SCOTTISH FOUNDATION, INC. ("ASF") CONFLICT OF INTEREST POLICY STATEMENT OF OTHER CORPORATE AND TRANSACTIONAL RELATIONSHIPS

## 1. EXPLANATION

The New York State Non for Profit Corporation Law, §715-a, dictates that, before joining the nonprofit and annually thereafter, each Board Member must complete, sign and submit to the nonprofit's Secretary, a written statement, that:



The ASF's Secretary shall provide a copy of all completed statements to the Chair of the Audit Committee or if there is none, to the full Board.

Although, technically, the law is concerned only with those organizations and transactions where the Board Member believes they have or may have a COI or RPT with the nonprofit, in practice, this requires a full disclosure of the Board Member's other involvements.

Unfortunately, this extra disclosure and added paperwork is one of the unique burdens of public service that others do not bear. However, please remember this is necessary to ensure the **transparency, fairness and protection** of the nonprofit's activities and assets ("TFP"). The more honesty and fair dealing the ASF provides, the better its delivery of services will be, and the greater the trust of the authorities that regulate it and the public that supports it. So, your cooperation in completing these forms, accurately and fully, is not only required, but greatly appreciated by those who ultimately will benefit from your service.
